Saskatchewan or either of them from and against any future expenses, damages, claims, demands or judgments concerning this road or street.

- 4. The Purchaser agrees to
  - a) incur all costs to convey title to the land from the crown under care of the municipality.
  - b) Be responsible for all Information Services Corporation (ISC) fees related to the transfer of the lands; and
- 5. The Purchaser shall, without charge, grant utility line easements as may be required by the Saskatchewan Power Corporation, Sask Energy and Saskatchewan Telecommunications for any existing lines.
